The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages typically libraries of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Most GNU software, including some libraries, is covered by the ordinary GNU General Public License. This license, the GNU Lesser General Public License, applies to certain designated libraries, and is quite different from the ordinary General Public License. We use this license for certain libraries in order to permit linking those libraries into non-free programs.

**11.** If, as a consequence of a court judgment or allegation of patent infringement or for any other reason (not limited to patent issues), conditions are imposed on you (whether by court order, agreement or otherwise) that contradict the conditions of this License, they do not excuse you from the conditions of this License. If you cannot distribute so as to satisfy simultaneously your obligations under this License and any other pertinent obligations, then as a consequence you may not distribute the Library at all. ## zlib 1.1.4 License

zlib 1.1.4 is a general purpose data compression library. All the code is thread safe. The data format used by the zlib library is described by RFCs (Request for Comments) 1950 to 1952 in the files <http://www.ietf.org/rfc/rfc1950.txt> (zlib format), [rfc1951.txt](http://www.ietf.org/rfc/rfc1951.txt) (deflate format) and [rfc1952.txt](http://www.ietf.org/rfc/rfc1952.txt) (gzip format). These documents are also available in other formats from [ftp://ftp.uu.net/graphics/png/documents/zlib/zdoc-index.html](http://ftp.uu.net/graphics/png/documents/zlib/zdoc-index.html)

All functions of the compression library are documented in the file `zlib.h` (volunteer to write man pages welcome, contact [jloup@gzip.org](mailto:jloup@gzip.org)). A usage example of the library is given in the file `example.c` which also tests that the library is working correctly. Another example is given in the file `minigzip.c`. The compression library itself is composed of all source files except `example.c` and `minigzip.c`.

To compile all files and run the test program, follow the instructions given at the top of `Makefile`. In short “make test; make install” should work for most machines. For Unix: “./configure; make test; make install” For MSDOS, use one of the special makefiles such as `Makefile.msc`. For VMS, use `Make_vms.com` or `descrip.mms`.

The changes made in version 1.1.4 are documented in the file ChangeLog. The only changes made since 1.1.3 are bug corrections:

- ZFREE was repeated on same allocation on some error conditions.  
This creates a security problem described in <http://zlib.net/advisory-2002-03-11.txt>.
- Returned incorrect error (Z\_MEM\_ERROR) on some invalid data.
- Avoid accesses before window for invalid distances with inflate window less than 32K.
- force windowBits > 8 to avoid a bug in the encoder for a window size of 256 bytes. (A complete fix will be available in 1.1.5).

The beta version 1.1.5beta includes many more changes. A new official version 1.1.5 will be released as soon as extensive testing has been completed on it.

Notes for some targets:

- To build a Windows DLL version, include in a DLL project zlib.def, zlib.rc and all .c files except example.c and minigzip.c; compile with -DZLIB\_DLL The zlib DLL support was initially done by Alessandro Iacopetti and is now maintained by Gilles Vollant <info@winimage.com>. Check the zlib DLL home page at <http://www.winimage.com/zLibDll/index.html>.  
From Visual Basic, you can call the DLL functions which do not take a structure as argument: compress, uncompress and all gz\* functions. See contrib/visual-basic.txt for more information, or get the cmp-z-it.zip file from <http://www.winimage.com/zLibDll/index.html>.
- For 64-bit Irix, deflate.c must be compiled without any optimization.  
With -O, one libpng test fails. The test works in 32 bit mode (with the -n32 compiler flag). The compiler bug has been reported to SGI.
- zlib doesn't work with gcc 2.6.3 on a DEC 3000/300LX under OSF/1 2.1 it works when compiled with cc.
- on Digital Unix 4.0D (formerly OSF/1) on AlphaServer, the cc option -std1 is necessary to get gzprintf working correctly. This is done by configure.
- zlib doesn't work on HP-UX 9.05 with some versions of /bin/cc. It works with other compilers. Use "make test" to check your compiler.
- gzdopen is not supported on RISCOS, BEOS and by some Mac compilers.

- For Turbo C the small model is supported only with reduced performance to avoid any far allocation; it was tested with -DMAX\_WBITS=11 -DMAX\_MEM\_LEVEL=3
- For PalmOs, see Per Harald Myrvang (perm@stud.cs.uit.no).
