

End-of-Sale and End-of-Life Announcement for the Cisco IP Mobility Gateway Feature License and Cisco Mobile Client

Cisco Systems® announces the end-of-sale and end-of life dates for the Cisco IP Mobility Gateway Feature License and Cisco Mobile Client. The last day to order the Cisco IP Mobility Gateway Feature License is June 18, 2007. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the Cisco IP Mobility Gateway Feature License. The Cisco Mobile Client is no longer available to download. The End of SW Maintenance Release Date and Last Date of Support for the Cisco Mobile Client are July 1st 2007. Table 2 lists the product part numbers affected by this announcement.

End-of-Life Announcement Date	The date the document that announces the end of sale and end of life of a product is distributed to the general public.	June 18, 2007
End-of-Sale Date	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	June 18, 2007
Last Ship Date: App. SW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	June 18, 2007
End of SW Maintenance Releases Date: App. SW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	July 1, 2007

products. Customers can consider a third-party client, such as the Birdstep Intelligent Mobile IP Client (<http://www.birdstep.com>) and the ipUnplugged Roaming Client (<http://www.ipunplugged.com>), to provide functions similar to those of Cisco Mobile Client.
