

# End-of-Sale and End-of-Life Announcement for the Cisco 1-Port OC-12c/STM-4c POS Shared Port Adapter

Cisco announces the end-of-sale and end-of-life dates for the Cisco 1-Port OC-12c/STM-4c POS Shared Port Adapter. The last day to order the affected product(s) is September 6, 2013.
