

## End-of-Sale and End-of-Life Announcement for the Cisco 1-Port OC-12c/STM-4c ATM Shared Port Adapter

Cisco announces the end-of-sale and end-of life dates for the Cisco 1-Port OC-12c/STM-4c ATM Shared Port Adapter. The last day to order the affected product(s) is December 20, 2011. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

<b>End of Service Contract Renewal Date: HW</b>	The last date to extend or renew a service contract for the product.	March 19, 2016
<b>Last Date of Support: HW</b>	The last date to receive service and support for the product. After this date, all support services for the product are unavailable, and the product becomes obsolete.	December 31, 2016
