



## End-of-Sale and End-of-Life Announcement for the Cisco Secure Access Control System 5.1

Cisco announces the end-of-sale and end-of life dates for the Cisco Secure Access Control System 5.1. The last day to order the affected product(s) is May 21, 2012.
