

# End-of-Sale and End-of-Life Announcement for the Cisco Prime for IP Next Generation Networks 1.0 and 1.1

Cisco announces the end-of-sale and end-of-life dates for the Cisco Prime for IP Next Generation Networks 1.0 and 1.1. The last day to order the affected product(s) is May 6, 2014.
