



## End-of-Sale and End-of-Life Announcement for the Cisco Intelligent Automation for Cloud—Compute 2.0

Cisco announces the end-of-sale and end-of life dates for the Cisco Intelligent Automation for Cloud - Compute 2.0. The last day to order the affected product(s) is May 1, 2012.
