End-of-Sale and End-of-Life Announcement for the Cisco ONS 15454 Triple Play Bundles

Cisco Systems® announces the end-of-sale and end-of-life dates for the Cisco® ONS 15454 Triple Play Bundles. The last day to order the affected product is November 1, 2005. This announcement pertains to the specified bundle part numbers only and not to any other part of the Cisco ONS 15454 platform.
