# **Product Migration Options**

There is no replacement available for the Cisco TelePresence IP Gateway at this time.

Although there is no direct replacement for the Cisco TelePresence IP Gateway, it did offer firewall-bypass functionality, dial plans, and a video automated attendant/IVR. The Cisco TelePresence VCS Control and Expressway are the recommended products for firewall traversal and dial plans. Added to this, from version X7 the Cisco TelePresence Video Communication Server offers an indirect replacement of the video automated attendant through a policy server toolkit that effectively provides customers with the ability to define and manage incoming call policies with such things as hunt groups and other value-added features.

Customers may be able to use the Cisco Technology Migration Program (TMP) where applicable to trade-in eligible products and receive credit toward the purchase of new Cisco equipment.
