Cisco announces the end-of-sale and end-of-life dates for the Tandberg Classic 27-inch and 27-inch Dual. The last day to order the affected product(s) is January 30, 2005. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.
