

End-of-Sale and End-of-Life Announcement for the Tandberg Justice 3000 MXP

Cisco announces the end-of-sale and end-of-life dates for the Tandberg Justice 3000 MXP. The last day to order the affected product(s) is January 30, 2005. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	April 30, 2005
