

## End-of-Sale and End-of-Life Announcement for the Tandberg Border Controller Upgrade Licenses

<b>Last Ship Date: App. SW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	December 22, 2013
<b>End of SW Maintenance Releases Date: App. SW</b>	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	September 23, 2014
<b>End of New Service Attachment Date: App. SW</b>	For equipment and software that is not covered by a service-and-support contract, this is the last date to order a new service-and-support contract or add the equipment and/or software to an existing service-and-support contract.	September 23, 2014

<b>Last Date of Support: App. SW</b>	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	September 30, 2016

There is no replacement available for the Tandberg Border Controller Upgrade Licenses at this time.

No replacement upgrade licenses are available for Tandberg Gatekeeper and Tandberg Border Controller. However, customers of Tandberg Gatekeeper and Tandberg Border Controller looking for solution upgrades should migrate to Cisco VCS Control and Cisco VCS Expressway, respectively.
