Cisco announces the end-of-sale and end-of-life dates for the Tandberg Portable 3000 MXP. The last day to order the affected product(s) is July 1, 2009. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	September 29, 2009
