

End-of-Sale and End-of-Life Announcement for the Tandberg Tactical MXP

Cisco announces the end-of-sale and end-of-life dates for the Tandberg Tactical MXP. The last day to order the affected product(s) is January 31, 2010. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	May 1, 2010
End of Routine Failure Analysis Date: HW	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	January 31, 2011
