

End-of-Sale and End-of-Life Announcement for the Cisco 851 Integrated Services Router

Cisco announces the end-of-sale and end-of life dates for the Cisco 851 Integrated Services Router. The last day to order the affected product(s) is July 15, 2010. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	October 13, 2010
End of SW Maintenance Releases Date: HW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	July 15, 2013
