

# End-of-Sale and End-of-Life Announcement for the Select Ethernet Modules for Cisco Integrated Services Routers

EOL8695 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Select Ethernet Modules for Cisco Integrated Services Routers. The last day to order the affected product(s) is February 13, 2013. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

<b>Last Ship Date: HW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	May 14, 2013
<b>End of SW Maintenance Releases Date: HW</b>	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	February 13, 2014

After this date, all support services for the product are unavailable, and the product becomes obsolete.	February 28, 2018
