

## End-of-Sale and End-of-Life Announcement for the Cisco SR2016 16-Port 10/100/1000 Gigabit Switch (Taiwan)

Cisco announces the end-of-sale and end-of life dates for the Cisco® SR2016 16-Port 10/100/1000 Gigabit Switch (Taiwan). The last day to order the affected product(s) is July 28, 2010. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.
