



## End-of-Sale and End-of-Life Announcement for the Cisco Nexus 3064PQ Switch

Cisco announces the end-of-sale and end-of life dates for the Cisco Nexus 3064PQ Switch. The last day to order the affected product(s) is January 30, 2013.
