Cisco announces the end-of-sale and end-of-life dates for the Cisco DDR2200, DDR2201, and WAG310G ADSL2+ Residential Gateways. The last day to order the affected product(s) is June 8, 2012. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions, even if this date exceeds the Last Date of Support shown in Table 1.
