



## End-of-Sale and End-of-Life Announcement for the Cisco ROSA Device Configuration Shell (DCS)

For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions, even if this date exceeds the Last Date of Support shown in Table 1.
