

# End-of-Sale and End-of-Life Announcement for the Regulus Statistical Multiplex Controller

Cisco announces the end-of-sale and end-of-life dates for the Regulus Statistical Multiplex Controller. The last day to order the affected product(s) is November 13, 2012.
