Cisco announces the end-of-sale and end-of life dates for the Cisco Digital Media Encoders 1100 and 2200. The last day to order the affected product(s) is July 31, 2012. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.
