Cisco announces the end-of-sale and end-of life dates for the Cisco Show and Share 5.2 on C200/C210 M2 Hardware. The last day to order the affected product(s) is March 4, 2013. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

Existing customers are encouraged to upgrade to Cisco Show and Share 5.3. New Cisco Show and Share customers should order the Cisco MXA UCS C220 M3 Rack Server for Cisco Show and Share Deployments, which comes with the latest 5.3 software.
