Chris Borroni-Bird is the driving force behind GM's "Reinvention of the Automobile" program, which includes the Autonomy, Hy-wire and Sequel concept vehicles. More recent work on Personal Urban Mobility and Accessibility (P.U.M.A) and Electric Networked Vehicle (EN-V) has extended this "Reinvention of the Automobile" to include connectivity so that all urban mobility challenges (energy, environment, safety, congestion, parking and affordability) can be addressed. This vision is featured prominently in the GM-SAIC Pavilion at the 2010 Shanghai World Expo. He is also the co-author of the book "Reinventing the Automobile: Personal Urban Mobility for the 21st Century" (with Prof. Bill Mitchell and Dr. Larry Burns) that was published by MIT Press in March 2010.
