This Master Agreement Addendum governs Cisco Systems, Inc's (hereinafter "CONTRACTOR") use of the WSCA-NASPO name and logo (defined and listed in Appendix 1, below) during the term of the referenced Master Agreement and amendments to that Master Agreement. CONTRACTOR may use the name and logo only as set forth below. Any use not expressly permitted herein is prohibited, and such use constitutes a material breach of the Master Agreement with the Lead State and all Participating States.

- CONTRACTOR may display the WSCA-NASPO name and logo on the face of the Master Agreement, including all electronic and hard copy 17 versions.
- CONTRACTOR and its subcontractors, resellers, and agents may display the WSCA-NASPO name and logo on a web site as a "click on" link 20 to the Master Agreement and on the website CONTRACTOR maintains as required by Section 4.3 of the original solicitation. No other use of the logo or name is permitted on any web site, except as permitted in paragraphs 1 and 3.
- With, and only with, prior written approval of the Cooperative Development Coordinator, working with the Lead State Contract 3-Administrator, CONTRACTOR may advertise the Master Agreement in publications and promotional materials aimed at state, local government and other eligible entities eligible to use the Master Agreement. The sole focus and intent of such advertisements must be to increase participation in the Master Agreement. The WSCA-NASPO name may be used and the logos displayed in the advertisement ONLY as it relates to the Master Agreement. The WSCA-NASPO Cooperative Development Coordinator's approval must encompass the content and appearance of the advertisement and the media in which the advertisement will appear.
- CONTRACTOR may not make explicit or implicit representations concerning the opinion of WSCA-NASPO, the Lead State, or any 4. Participating State regarding CONTRACTOR or its products or services. This restriction includes general use of the WSCA-NASPO name and logo NOT directly linked to or related to this Master Agreement.
- CONTRACTOR will require that its sub-contractors, resellers, and agents adhere to the terms of this Addendum, and CONTRACTOR is 5. responsible for any breach by these entities.
- CONTRACTOR must immediately cease all use of the WSCA-NASPO name and logo within ten (10) business days if directed to do so in 6. writing by the WSCA-NASPO Cooperative Development Coordinator, and CONTRACTOR will require that its sub-contractors, re-sellers, and agents immediately cease all use within the said timeframe.
- 7. CONTRACTOR shall not make, or permit its subcontractors, resellers, or agents to make, any alterations to WSCA-NASPO's name or logo (including characters, style and colors) and CONTRACTOR shall not use or permit the use of WSCA-NASPO's name or logo in a manner or context that could adversely affect WSCA-NASPO's integrity, goodwill, or reputation.
- 8. Upon termination or expiration of the Master Agreement, CONTRACTOR and its sub- contractors, re-sellers, and agents must cease all use of the WSCA-NASPO name and logo; except that, CONTRACTOR may use the WSCA-NASPO name for reference purposes in a description of its prior experience.
